- ?? Three minute dinghy start sequence will be used.
- ?? There will be a minimum of (2) races for each class, conditions permitting. Optimists will sail on Saturday in Stites Sound which is about a 20 minute sail from the club
- ?? All other races will be held in the Great Sound, which is about a 45 minute sail from the club depending on conditions. Patrol boats may be available to tow sailors out but a tow can not be guaranteed.
- ?? Course information and local rules to be provided at skipper's meeting or upon request.
- ?? Cost is \$25.00 per Skipper, \$10.00 per Crew.

2. To release and save harmless, and does hereby release and save harmless the CLUB and MAYRA or any of them, their successors and assigns and/or officers, employees, and representatives of them, and/or officials of the EVENT, of and from all manner of claims, suits, causes of action, cost and damages whatsoever, which the APPLICANT may at any time have against them, or any of them, by reason of the EVENT and preparation for the EVENT and the APPLICANT'S participation therein; and

3. The APPLICANT does hereby assume all and full responsibility for any injury, damage or loss sustained by the CLUB and all persons performing duties or services in connection with the conduct of the EVENT and all spectators thereof, by reason of any act of failure to act by the APPLICANT or any of the APPLICANT'S crew or passengers; and further, the APPLICANT does hereby agree to save harmless the CLUB and MAYRA of and from all liability, suits, causes of action, claims, costs, and damages including but not limited to reasonable attorneys' fees by reason thereof.
